**OFFICE MEMORANDUM**

Direct recruitment to Class-III posts, both technical and non-technical, and Class-IV posts have to be carried out only by following the service rules.


Wherever such service rules are not present, the recruitment has to happen only in accordance with the prevailing latest executive orders.

Wherever there are no service rules or executive orders, the recruitment of Class-III posts, both technical and non-technical, and Class-IV posts should be in accordance with the Assam Public Service (Direct Recruitment to Class-III and Class IV Posts) Rules, 1997 only.

Administrative Department i.e. Health & F.W. Department shall form a Selection Committee with relevant instructions for qualifications for written test and interview. Without the duly constituted Selection Committee and the Administrative Department's instructions regarding selection procedure, no recruitment shall be made by any authority in the Health & Family Welfare Department.

Any recruitment made without following the above prescribed instructions shall be deemed as an illegal appointment and suitable steps will be taken against such appointing authorities for violation of the rules and FRBM Act.

Further, all the heads of offices under the Health & Family Welfare Department are to furnish information whether any recruitment have been made in violation of the above prescribed instructions in the last 5 years so that the same can be examined and appropriate decision be taken by the competent authority.


