NOTIFICATION

The 3rd May, 2010

No. HLB.170/2007/150. -- The Governor of Assam is hereby pleased to make the following rules further to amend the Medical Colleges of Assam, Regional Dental College, Guwahati and Government Ayurvedic College, Guwahati (Regulation of Admission of Under Graduate Students) Rules, 2007, hereinafter referred to as the principal Rules, namely:

Short Title, Commencement and Application.

- 1. (1) These rules may be called the Medical Colleges of Assam, Regional Dental College, Guwahati and Government Ayurvedic College, Guwahati (Regulation of Admission of Under Graduate Students) (Amendment) Rules, 2010.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
 - (3) They shall be applicable to regulate the admission of students to the MBBS/BDS/BAMS Courses in the Medical Colleges of Assam, the Regional Dental College, Guwahati and the Government Ayurvedic College, Guwahati respectively.

Amendment of Rule 2.

- 2. In the principal Rules, in rule 2, -
 - (i) in clause (b) shall be deleted;
 - (ii) in clause (p), for the punctuation mark ";", the punctuation mark ";" shall be substituted and thereafter new clauses (q), (r), (s) and (t) shall be inserted, namely:-

- (q) "Ex-Servicemen" means and includes the retired defence personnel governe by the definition as laid down from time to time by the Department of Personnel and Training, Government of India;
- (r) "Serving Defence Personnel" means those who are in continuous active service under the Ministry of Defence, whether in Army, Navy or Air Force;
- (s) "Waiting list" means the category-wise list of candidates according to merit in the CEE prepared after filling up of all the State Quota seats as referred to in rule 4(4) (a);
- (t) "All India Quota" means the seats reserved for the students selected by the Central Government through All India Entrance Examination mentioned in rule 5 (a) and rule 13."

Amendment of Rules 4.

- 3. In the principal Rules, in rule 4, sub-rule (3) for (i) in clause (h), the following shall be substituted, namely:-
 - (h) (i) After finalization of the provisional category-wise list of candidates for provisional admission into MBBS/BDS/ courses in the Medical Colleges of Assam and Regional Dental College, Guwahati along with the category-wise waiting list recommended by the Selection Board shall be forwarded to the Government for approval. Such approved category-wise provisional select list of candidates along with the category-wise waiting list shall be published in the leading newspapers by the Directorate of Medical Education, Assam.";
 - (ii) in sub-rule (4), for clause (a), the following shall be substituted, namely:-
- " (a) Any seat remaining vacant shall be filled up in the manner prescribed by Selection Board considering the merit criteria";
 - (iii) in sub rule (4), clause (b) shall be deleted and the existing clause (c) shall be re-numbered as clause (b).

Amendment of Rule 6.

- 4. In the principal Rule, in rule 6; -
 - (i) clause (m) (v) shall be deleted;
 - (ii) after sub-clause (m); a new clause (n) shall be inserted, namely:-
 - (n) "Ex-Servicemen and Serving Defence Personnel. 2 (two) seats of MBBS Course shall be reserved for the sons and daughters of the Ex-Servicemen and Serving Defence Personnel from Assam, only at Silchar Medical College, Silchar from the session 2010.";
 - (iii) after sub-clause (1), after the existing proviso, the following proviso shall be inserted, namely:-

"Provided further that in case there is dearth of candidates in the range of 50% to 70% disability of lower limbs under Physically Disabled category then candidates with disability of lower limbs between 40% to 50% shall be considered for admission vide Government of India's letter No. C.18018/V/2009-ME(Pt.I), dated 17th February, 2009."

The student shall diligently Prosecute and complete the said course at the said college or in any other Medical College/Regional Dental College, in the State and passed the prescribed University Examination for the said course, and

mmediately after completion of Rotatory internship of a student, the Government of Assam would offer a Posting in the State Health Service and it will be binding upon the student to join the said ost within a period of 15 (fifteen) days from the date of posting order.

Provided that the students will submit their option regarding service in Rural Area/other as of the State at least one month before completion of the internship training to the Principal of respective Medical Colleges for forwarding the same to the Government for consideration le issuing appointment order.

And upon making of such payment of above written obligation shall be paid and of no effect otherwise it shall be remain in full force.

Provided further that the liability of the surety hereinunder shall not be impaired or discharged by the reason of time being granted or forbearance or commission of the Government (with or without the knowledge or consent of the surety) in respect of or in relation to several obligations and conditions to be performed or discharges by the student or Father/Natural Gurdian of a minor student suing the surety for amounts hereunder and provided further that this bond shall in all respect to be governed by the Laws of India. The express of the stamp duty on the Bond if any, shall be borne by the Government.
