**ORDERS BY THE GOVERNOR  
NOTIFICATION**

Dated Dispur the 6<sup>th</sup> January, 2018

No. HLA 1084/2017/80: - Whereas, the State Government in Health and Family Welfare Department has constituted the Medical and Health Recruitment Board, an autonomous body under the Health and Family Welfare Department whose function is to make recommendations for appointment to the categories of posts under Health and Family Welfare Department which are identified for recruitment through the Medical and Health Recruitment Board.

Whereas, the posts of Inspector of Drugs has been identified for recruitment through the Medical and Health Recruitment Board and the same has been approved by the State Cabinet.

Whereas, the Assam Public Service Commission (Limitation of Functions) (Amendment) Regulations, 2017 has been notified wherein the post of Inspector of Drugs has been inserted in the SCHEDULE to the Regulations.

Whereas, the qualifications prescribed in the Schedule –II of the Assam Drugs Control Organisation Service Rules, 1994 are not in consonance with the qualifications of Inspectors laid down in the Drugs and Cosmetics Rules, 1945 (as amended).

Now, therefore, in exercise of the powers conferred by the proviso to Article 309 of the Constitution of India the Governor of Assam is hereby pleased to make the following Rules further to amend the Assam Drugs Control Organisation Service Rules, 1994, hereinafter referred to as the principal Rules in the manner hereinafter appearing, namely: -

“(c) “Recruitment Board” means the Medical and Health Recruitment Board (MHRD), an autonomous body constituted by the State Government in Health and Family Welfare Department with its, structure and functions vide notification No.HLB.57/91/Pt-IV(A)/194 dated 25<sup>th</sup> October, 2017;”.


(2) In the principal Rules, for the word “Commission” wherever it occurs, the words, “Recruitment Board” shall be substituted.

Amendment of Schedule II 3. In the principal rules, for the existing SCHEDULE-II, the following shall be substituted, namely,-

“SCHEDULE-II

(Rule-8)

A candidate must have a degree in Pharmacy or Pharmaceutical Sciences, or Medicine with specialization in clinical Pharmacology or, Microbiology from a University established in India by law.”
