SPEAKING ORDER

READ : (1) Petition dated 29th September, 2021 submitted by Dr. Achintya Kumar Baruah, M&HO-I, Kanaklata Civil Hospital, Tezpur, for closure of the pending Departmental Proceeding against him.
(2) Show Cause Notice issued to Dr. Achintya Kumar Baruah, M&HO-I, Kanaklata Civil Hospital, Tezpur vide Govt. letter No. HLA.873/2011/10 dated 16/01/2013.

ALSO READ : (1) Explanation of Dr. Achintya Kumar Baruah regarding the Departmental Proceeding against him dated 18/12/2017.

FINDINGS : (1) Dr. Achintya Kumar Baruah joined as M&HO-I under Regulation 3(f) Of APSC on 25/01/1994.
(2) His service was regularized w.e.f. 25/07/1995
(3) His date of retirement (as M&HO-I) is 30/04/2022
(4) He has been drawing his salary with increments in the scale of M&HO-I.
(5) Show cause notice was issued to Dr. Achintya Kumar Baruah, M&HO-I, vide Govt. letter no. HLA.873/2011/10 dated 16/01/2013 for his alleged misbehavior with a patient named Smti. Pabita Newar and also with one inquiry officer in the rank of SDO (Sadar).
(6) Dr. Achintya Kumar Baruah, M&HO-I, vide his letter dated 18/12/2017 submitted his explanation regarding the alleged charges levied against him.
(7) Due to the pending departmental proceeding, he was not granted promotion or any kind of financial benefit during his years of service although his service was regularised in July,1995.

ORDER : On perusal of records, it appears that the charges of misbehavior levied against Dr. Achintya Kumar Baruah are not of grave nature. Also, the said charges could not be established. Moreover, Dr. Achintya Kumar Baruah, M&HO-I did not get his promotion during his entire service life although he was eligible for promotion as per Rule 11 (2) of the Assam Health Service Rules, 1995.

Therefore the Govt. in Health & Family Welfare Department is pleased to dispose of the Departmental Proceeding drawn up against Dr. Achintya Kumar Baruah, M&HO-I, with the following decisions:

1. Dr. Achintya Kumar Baruah, M&HO-I, is exonerated from the charges levied against him. However he is hereby strictly cautioned to be more vigilant towards his patients and fellow Govt. officials.
2. Dr. Achintya Kumar Baruah, M&HO-I, is hereby granted Fixed Time Scale as per Govt. notification issued vide No.HLA.668/2017/15 dated 25th September, 2017.

The above matter of Dr. Achintya Kumar Baruah, M&HO-I is closed henceforth.


